

Below is a personalized status update for the City of Garden Grove. Since the enrollment of the City in May 2017, SoCalREN Public Agency Programs have worked with the agency to improve its energy efficiency and save money. To date, this collaboration has saved 1% of overall electric energy usage and 0% of overall gas energy usage<sup>1</sup>. Given recent enrollment there are a number of projects in the pipeline and many to explore to expand on energy efficiency.
